Pacific Northwest Regional Council of Carpenters OFFICIAL SCHOLARSHIP FUND APPLICATION

The purpose of the scholarship is to provide financial assistance to <u>FULL TIME</u> (12 credits for most institutions) students pursuing an education beyond high school for the 2022-2023 school year and may not be used for any other purpose (e.g. paying on a student loan). Scholarship must be used by the student either Fall 2022 or deferred to Winter 2023 quarter/semester only. NO OTHER USE OR DEFERRAL IS ACCEPTABLE.

TO BE ELIGIBLE:

- 1. Applicant's sponsoring family member <u>must have voting rights</u> (must be a living member and must not be in arrears) at their Local Union during the entire application process. Applications are available on the website: www.nwcarpenters.org under Member Resources.
- 2. Applicants must be <u>children</u>, <u>adopted children</u>, <u>step children or grandchildren of a PNWRCC member</u>. No other relationships will be considered for scholarship. The <u>UBC ID #</u> of the **PNWRCC** sponsoring member must be included on the application. A recipient is limited to one award per year, although eligible students may apply each year.
- 3. The application must be made on the official <u>PNWRCC</u> application form and must be <u>postmarked or dated</u> no later than <u>FRIDAY</u>, <u>FEBRUARY 25, 2022</u> to be considered for an award. <u>Applications WILL</u> be accepted via USPS, email, fax or private carrier (e.g. UPS, FedEx).
- 4. The Scholarship Committee shall make the selections. A panel of judges will review and score the applications. A blind system will be used where only the Executive Secretary-Treasurer may know the identity of the applicant to ensure anonymity. Award amounts are based on three categories: scholastic achievement, financial need, and an overall review of the student which includes their application presentation, essay, community involvement, and school activities (see #6 below).
- 5. Payment of the award shall be made directly to the school of the recipient's choice upon submission of verified registration at an approved school. (See "ONCE THE SCHOLARSHIP RECIPIENTS HAVE BEEN SELECTED" on page 3 for more details.) The scholarship award <u>MUST</u> be used during the academic period for which it has been designated. It cannot be used to pay on current student loans. No deferrals will be allowed beyond Winter 2023 quarter/semester. If the student has not accessed the scholarship monies by Winter Quarter/Semester 2023, the monies will be returned to the scholarship fund and the scholarship will be considered forfeited. Extenuating circumstances will be examined on a case by case basis.

If a student is aware of when he/she will be registering for classes and when tuition is due, please write those dates on page 2 of this application where indicated or let Rosa Plong (253-266-4386) know as soon as possible so we can accommodate payment of your scholarship for disbursement Fall 2022.

- 6. Along with the completed application, <u>ALL APPLICANTS</u> are <u>REQUIRED</u> to submit the following (■) documents:
- TRANSCRIPTS (Need not be official, online transcripts are acceptable)
- A FAFSA <u>STUDENT AID REPORT</u>. A <u>COMPLETED</u> copy of your 2021-22 FAFSA (Federal Application For Student Aid) will generate a <u>Student Aid Report</u> which shows the <u>EFC</u> (Expected Family Contribution). <u>The EFC is required in order to apply for the PNWRCC Scholarship</u>. - THREE STATEMENTS/LETTERS OF RECOMMENDATION. All Statements/Letters of recommendation must be <u>CURRENT</u> (dated between 3/1/2021 and 2/25/2022) and printed on letterhead with contact information included. Students may submit additional letters of recommendation beyond those required as noted below (i.e. coaches, clergy, employers, etc.).
 - ◆ HIGH SCHOOL APPLICANTS: Current letters of recommendation, dated within the current application time frame from two instructors and a counselor/advisor are required for high school applicants.
 - ♦ COLLEGE APPLICANTS: Applicants already attending college should make every attempt to acquire letters of recommendation from two instructors and an advisor. However, if letters from instructors or advisors are unattainable, the three required current letters of recommendation may be from others (i.e. coaches, clergy, employers, etc.) with no family relationship to the applicant. (We understand that college students may not have the same rapport with instructors or advisors as high school students.)
- THE ESSAY. The granting of a scholarship shall be partially based on an original essay of 500 1000 words. See page 2 for more details.
- ANSWER THE SEVEN QUESTIONS/INQUIRIES ON PAGE 2.

If transcripts or other documents are sent separately, they also must be postmarked or dated no later than FRIDAY, FEB. 25, 2022.

Recipients will be notified of procedures for disbursement of scholarship funds. Every effort will be made to accommodate a recipient's payment schedule (See #5 on page 1).

Documentation needed is:

- 1) verification of full time enrollment in a college, university, or trade school (or continued enrollment in the case of recipients already in college);
- 2) student ID # assigned to you by your chosen school;
- 3) the address of the financial aid office at that institution;
- 4) for high school students only, a copy of their high school diploma; for college students only, a copy of their last completed quarter transcripts (need not be official transcripts);
- 5) a photo of the award winner preferably with the sponsoring family member or whole family and a short 50-100 words bio for publication in our magazine and other kinds of media (e.g. website). The Council may use this photo and other submitted materials for promotion of our scholarship unless the member or student objects to that use and submits to the Scholarship Committee in writing a request to not use their photo for promotional purposes.
